## TERMS & CONDITIONS OF MEMBERSHIP

This application is for a seasonal golf membership only. The Meadow Nest course may be played from season's opening to the end of October (weather and conditions permitting). The Timber Ridge and Hawk's Island courses may open later and close earlier in the season. Seasonal members and guests are bound by the usual rules of the golf course as amended and posted from time to time including and without limiting the generality of the foregoing, the following:

### 1) Exclusion of Liability - Assumption of Risk

As a condition of use of the golf course facilities, the golfer assumes all risk of personal injury, death or property loss resulting from any cause whatsoever including but not limited to the inherent risk of golfing, collision with natural or man - made objects or other golfers, travel within or beyond the golf area boundaries or negligence on the part of Hawk Ridge Golf & Country Club, it's agents or employees, The golfer agrees to save harmless Hawk Ridge Golf & Country Club, it's agents & employees and waives all claims with respect thereto.

### 2) Use and Operation of Power Carts

For and in consideration of the use of a golf cart, I promise and agree to return the said golf cart immediately following the completion of play, in as good condition as I received same, normal wear being excepted. I promise to abide by all Cart Path regulations as stipulated.

I promise and agree to pay for any damages that are sustained to the said golf cart while the same is in my possession.

I agree to hold Hawk Ridge Golf & Country Club harmless from any claims of any nature whatsoever that may arise through the use of a power cart. The member assures Hawk Ridge that they are familiar with the use of a power cart and that they can operate and control the same and further that the carts may only be operated within the limits of the golf course area excluding the parking lot. I agree to reimburse and indemnify Hawk Ridge for any payments to Third Parties that the club may be required to make as a result of damage or injury caused while cart is in my care.

### 3) Tee Time Reservation Policy

Any member, who reserves a tee time and fails to cancel prior to 24 hours before said time, will be required to pay the posted green fee rate for all unused tee time reservations. All members are required to provide Hawk Ridge Golf & Country Club with a valid credit card number at the time of signing such membership, authorizing deduction of the aforesaid charge, and releasing Hawk Ridge Golf & Country Club for such charges so levied.

All members are required to check-in at the Pro Shop prior to a Tee Time.

### 4) GAO Dues

Membership does not include access to the Golf Association of Ontario (GAO) and the Ontario Golf Information Network (OGIN) Handicap System. This service can be obtained by completing the attached Amenities Form accompanied by the appropriate fee.

### 5) Membership Renewal, Upgrade and Refund Policy

Full payment of applicable membership dues and taxes along with a completed renewal form must be received no later than 5pm on December 19, 2007 (in order to receive applicable discounts). Failure to renew by said date will result in member being subject to the regular posted 2008 membership rates. Any upgrade, deferral or transfer in membership categories and dues after renewal, will be subject to an administration fee of \$75.00, pro-rated and all upgrades are subject to availability. Requests for membership refunds must be submitted in writing & will only be considered in the event of death or serious health situations. Hawk Ridge reserves the right to arbitrarily cancel a membership if the behaviour of said member is found to be inappropriate / detrimental or if the member does not adhere to the terms & conditions.
